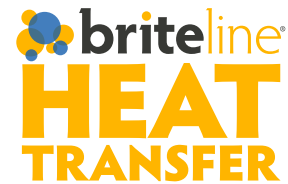

### Description

BriteLine® HTV G-Flex Ultimate Print Transparent Soft 234 is a 2 mil, matte, transparent, printable heat transfer film with non-adhesive liner. G-Flex Ultimate Print Transparent Soft 234 is a two-layer transfer film coated with hotmelt on the non-covered printable side. It is compatible with all current printers using eco-solvent, solvent and latex inks. The PET liner allows even filigree motifs to cut by all current CAD/CAM plotters after printing. After weeding the heat transfer is done with the original carrier. A matt PET-film on top of the image during the thermal transfer gives a brilliant semi-matt finish. After heat-transfer we recommend removing the PET-liner after a short period of cooling down to room temperature. The raw materials are ecologically inert, do not contain PVC, plasticizers or heavy metals (in accordance with OEKO-TEX STANDARD 100 Class I).
